INTRODUCTION & PURPOSE

The FOSFA International "Stuart Logan" Bursary, in partnership with the Worshipful Company of Tallow Chandlers awards individuals who are in full-time employment of a FOSFA member or non-member company whose main activity is in trading, shipping, dealing, brokering, superintending or analysis of oilseeds, oils or fats.

The purpose of the Bursary award is to promote skills and knowledge excellence in the oilseeds, oils and fats trade by enabling applicants to attend one of FOSFA International's residential education courses in London.





Applicants must be in full-time employment within the oilseeds, oils and/or fats trade.



Applicants' must provide proof of recent work achievements and a supporting reference/endorsement for their application.

Applicants must be eligible to travel to the UK.

WHAT DOES THE **BURSARY INCLUDE?**

Each of the six annual bursary awards will be for a maximum of up to £2,500 each.

The award is intended to cover the following costs:

- Course Fee(s) including tutoring, accommodation and meals.¹
- Transport costs to and from London (Economy flights only).²
 - Associated travel fees such as visa application.²

Transport costs from the arrival destination (e.g., airport, station) to the University campus venue.²

Note:

1 Course fees, accommodation and meals will be paid on behalf of the bursary holder by FOSFA International from the bursary fund.

2 Travel and transportation costs will be re-imbursed to the bursary holder on presentation and validation of a formal receipt(s).

HOW & WHEN ARE **AWARDS GRANTED?**

Bursaries will be awarded for the September courses at the end of March of the same year.

Applicants must apply by completing an official application form provided online or in hard copy by FOSFA International.

Applications will be reviewed and assessed by the FOSFA / Tallow Chandlers Liaison Committee. Their decision will be final.

TERMS & CONDITIONS

- 1. A photograph of the applicant must be submitted with the application.
- 2. The applicant must attend the entire period of the course.
- 3. The application form must be completed and submitted by the deadline Monday 11 March 2024 (or it will not be considered).
 - 4. The application must include a supporting reference from the candidate's immediate Line Manager or their superior.
- 5. The applicant must be eligible to travel to the UK.
- 6. The Bursary award is not renewable. Previous recipients of an award cannot re-apply.
- 7. All Applications must be submitted on the form supplied & countersigned by a manager of the applicant's employer confirming that the applicant is a bona fide full-time employee.
- 8. Successful candidates agree to provide a written and/or verbal testimonial of their experience as a course delegate.
- 9. Candidates agree to always conduct themselves in a professional manner during their involvement with FOSFA International or The Worshipful Company of Tallow Chandlers.
