

TRADE EDUCATION COURSES 2019

The Federation is pleased to announce that the 2019 residential Trade Education Courses will be held at Royal Holloway, University of London in the United Kingdom.

Under the Council adopted policy the newly named Advanced Course will run only in odd years, so 2019, 2021, 2023 etc, however the Basic Introductory Course will continue to run annually.

Royal Holloway is set amongst 135 acres of parkland in Egham, Surrey, and is located close to the M25, M4 Motorways, Heathrow and Windsor. It is also just a short train journey away from London's Waterloo Station.

The venue provides excellent facilities and a high level of support and service to our delegates, and we are pleased to say that the comments we received from the delegates who attended the Basic Introductory Course in 2017 was that, overall, the venue met their standards and needs.

CAREER DEVELOPMENT IN THE TRADE

Advanced Course 23-28 June 2019

A week-long management orientated course designed and structured to update delegates on current trade practices and regulations, as well as introducing a number of specialist managerial subjects, risk management case studies and group work.

FOSFA members and non-members can attend this course, which is aimed at managers with a minimum of three years' experience in the trade.

Basic Introductory Course 8-13 September 2019

A week-long elementary course covering aspects relating to the international trade in oilseeds, oils and fats. It is aimed at members of the trade and industry with no or little knowledge or experience in a trading environment and includes subjects such as FOSFA contracts, contract referred documents, arbitration and dispute resolution, shipping, trade finance and technical matters.

This course is open to FOSFA members and non-members and is aimed at new and junior members of the trade and service industries supporting the trade.

Both the Federation's courses are globally recognised in the oilseeds, oils and fats trades and will be held at Royal Holloway, University of London (www.venue.royalholloway.ac.uk/) at Egham, Surrey, in the UK.

Key note speakers from the trade and industry present the subjects and it is their enthusiasm and support that contributes much to the success of these courses.

The course fee includes instruction, accommodation (from Sunday to Thursday), meals (from Sunday evening to Friday lunchtime), use of gym and internet facilities, and is exceptional value for money.
